The Tassell Financial Planning Scholarship for Business & Finance

DETAILS

The purpose of the Scholarship is to provide an outstanding graduate of HVGS with a one year scholarship to assist them making a smooth transition to University Study.

The value of the Scholarship is for \$5,000. The Scholarship is tax free and will be paid in three instalments during the student's first year of University study. The first instalment being paid on 1 April with subsequent payments on 1 August and 1 October, based on the student's performance.

To be eligible to apply for this Scholarship a student must:

- > Have applied through UAC, or its equivalent to study Business and/or Finance at an Australian University in 2019.
- > Be able to demonstrate distinctive achievement at Stage 6.
- > Be a current student of HVGS, this Scholarship is only for students who will complete their HSC at HVGS in 2018.

Applicants will be interviewed in early November 2018. Students will be notified by phone and advised of dress requirements and preparation needed. The selection panel will comprise the Deputy Principal, Chair HVGS Scholarship Committee and the Dean of Innovative Curriculum. A Director of Tassell Financial Planning Pty Ltd, will be invited to join the panel as an observer.

The Scholarship will be presented to the successful scholar at the Year 12 Valedictory Dinner on Thursday 15 November 2018 by a representative of Tassell Financial Planning.

Scholarship offers are made conditional upon the scholar being offered a place in a relevant Business and Finance degree and subsequently taking up that offer and commencing study in 2019. A letter of offer will be sent to the successful scholar by 31 January of the scholarship year and must be signed and returned to the Principal, HVGS within 7 days of receipt.

Scholars are required to submit to the Dean of Innovative Curriculum, HVGS, a transcript of Semester 1, 2019 academic results no later than 7 days after the results become available.

The donor reserves the right not to award a Scholarship in any particular year if the quality of applications is not of a standard commensurate with the Scholarship.
